2. Tanya prefers English
3. Her email is [tcamiel@email.com](mailto:tcamiel@email.com)
4. Create her login name using the suggested structure and allow Tanya to enter her password, select the security questions and provide the answers

6. She does not want to share her information

### Income Follow-Up Questions

- 33. Tanya describes the professional activity as “mascot performer”
- 34. She enters the code 711510 for “performing artists”
- 35. Tanya does not have her own business name
- 36. Tanya does not have her own EIN
- 37. The business address is not different from the income earner’s home address
- 38. Tanya did not make any payments that required a form 1099
- 39. None of her self-employment income comes from being a notary public
- 40. She is not claiming any self-employment expenses – enter 0
- 41. None of the expenses are for a car or truck
- 42. She does not want help figuring out her total business expenses

### Deductions and Adjustments for Federal Taxes

- 43. Tanya did not pay any student loan interest
- 44. She did not pay alimony or separate maintenance
- 45. She did not pay any educator expenses
- 46. Tanya did not contribute to a Health Savings Account (HSA) nor have excess contributions in an HSA

- 47. She did not have any travel expenses as an Armed Forces Reservist, business expenses as a fee-basis government official, or business expenses as a performing artist
- 48. She did not contribute to a traditional IRA or have excess contributions in an IRA
- 49. She did not pay for health insurance coverage set up under her professional activity
- 50. Tanya did not pay tuition or fees for post-secondary education
- 51. None of her income is for foster care payments or Medicaid waiver payments
- 52. Tanya is not blind
- 53. She would like to take her standard deduction

*Tanya reviews her summary of taxable income, adjustments, and deductions.*

### **Credits for Federal Taxes**

- 54. She did not pay for any child care
- 55. She did not put money into an IRA or other plan
- 56. Tanya did not pay any mortgage interest

*She is not eligible for the Earned Income Tax Credit*

- 57. Tanya did not make any estimated federal income tax payments or apply last year's refund to this year's
- 58. Tanya did not file a form 4868 to request an extension to file

*Tanya reviews the summary of credits and payments*

### **Health Coverage and Premium Tax Credit**

- 59. Tanya's minimum essential coverage status is "Did not have coverage"
- 60. Tanya did not receive an exemption or exemption certificate
- 61. Tanya does not think that any of the exemptions apply to her

*Tanya is not eligible for the Premium Tax Credit. Her shared responsibility fee will be \$695.*

*The online service will say that Tanya owes taxes in the amount of \$1,140. (This includes her shared responsibility fee and the amount of taxes she owes on her self-employment income.)*

- 62. Tanya would like to e-file the return
- 63. Tanya would like to pay her taxes by credit or debit card

*Tanya selects the first website to use to pay her taxes.*

- 64. You are not filing this return as Power of Attorney
- 65. Her daytime telephone number is 614-555-5555
- 66. Her occupation is "Actor & Arcade Employee"
- 67. The IRS did not assign a 6-digit number to Tanya due to identity theft
- 68. Tanya would not like to designate another person to discuss the return with the IRS

*Tanya reviews her forms before printing.*

### **Ohio State Taxes**

- 69. Tanya is a full-time resident of Ohio
- 70. Tanya lived at 721 Imagine Ln Columbus, OH 43215 Franklin County all of last year

71. She did not move within Ohio last year

72. Her school district is Columbus CSD

*Tanya verifies that the residency summary is complete and correct*

73. Tanya was not paid back for any college tuition or fees during the tax year

74. Tanya was not paid back for any other expenses that were deducted in another year

75. She was not in the military last year

76. She did not need to pay back income earned in a previous year

77. She did not donate an organ last year

78. She did not contribute to anyone else's Individual Development Account

79. Tanya did not put money into anyone's CollegeAdvantage 529 nor did she have carryover amounts to deduct this year

80. She did not put money in a STABLE account, Ohio's ABLE Plan

81. Tanya did not pay any unreimbursed health care expenses

82. Tanya did not have an employer-paid or employer-subsidized accident and health plan for qualifying relatives last year

*Tanya verifies the taxable income summary*

83. Tanya did not lose a job in 2014, 2015, or 2016

84. Tanya did not donate to a political campaign last year

85. Tanya did not restore any historical buildings last year

86. Tanya did not make any Ohio state estimated tax payments last year

87. Tanya did not have part of last year's refund credited to this year's taxes

88. Tanya did not submit a filing extension request

89. She did not buy anything she did not pay sales tax on

90. She certifies that no sales or use tax is due

91. Tanya has never claimed the Ohio Lump Sum Retirement Credit

92. She would not like to donate \$1 to the Ohio Political Party Fund

93. She would like to donate \$5 to Wildlife Species

94. She will receive a state tax refund of \$91

95. She does not want to credit part of the refund to next year's tax return

### **School District Taxes**

96. The amount in Box 19 is withheld for city tax

*Tanya does not owe any school taxes*

### **Completing Your Ohio Return**

97. Tanya would like to e-file her state return

98. She agrees to the perjury statement

99. Tanya wants to direct deposit her Ohio refund

100. The account is located within the United States

101. Tanya chooses to have the money deposited into her personal savings

102. The routing number is **253177049**

103. The account number is **00123456789**

104. She accepts the terms of the direct deposit

*She is done printing and looking over her tax forms*

**E-file Submission**

105. She confirms her identity using last year's PIN: **77221**

106. She agrees to all the disclaimers and agreements

107. She chooses the same five digit PIN from last year

108. Tanya does not want to share her identification information
